SUBCONTRACTOR OR FABRICATOR SUBMITTING THE DRAWINGS INCLUDING CONTACT INFORMATION DRAWING IDENTIFICATION A PRECISE LIST OF ALL DRAWINGS SUBMITTED INCLUDING REVISION NUMBERS AND DATES DATE OF SUBMISSION CLEARLY STATING WHEN THE DRAWINGS WERE SUBMITTED REVIEW PERIOD SPECIFYING THE TIMEFRAME WITHIN WHICH THE DRAWINGS MUST BE REVIEWED AND APPROVED APPROVAL SIGNATURES SPACES FOR SIGNATURES AND DATES FROM THE RELEVANT STAKEHOLDERS TYPICALLY THE ARCHITECT ENGINEER AND GENERAL CONTRACTOR 2 REVISION TRACKING AREAS FOR DOCUMENTING REVISIONS CHANGES AND RESUBMISSIONS ACCEPTANCE/REJECTION STATUS A CLEAR INDICATION OF WHETHER THE DRAWINGS HAVE BEEN APPROVED OR REJECTED ALONG WITH REASONS FOR REJECTION KEY ELEMENTS OF A ROBUST SUBMITTAL FORM WHILE THE SPECIFICS MIGHT VARY BETWEEN PROJECTS AND COMPANIES A WELLSTRUCTURED SUBMITTAL FORM TYPICALLY INCLUDES PROJECT NAME AND NUMBER ESSENTIAL FOR UNAMBIGUOUS IDENTIFICATION SUBCONTRACTOR/FABRICATOR NAME AND CONTACT INFORMATION ALLOWS FOR EASY COMMUNICATION AND ACCOUNTABILITY DRAWING NUMBER AND REVISION ENSURES THAT THE CORRECT DRAWINGS ARE BEING REVIEWED DATE SUBMITTED TRACKS THE SUBMISSION TIMELINE DESCRIPTION OF WORK A BRIEF BUT CLEAR EXPLANATION OF WHAT THE DRAWINGS DETAIL RELEVANT SPECIFICATIONS AND CODES ENSURES COMPLIANCE WITH PROJECT REQUIREMENTS SUBMITTAL CHECKLIST A LIST OF REQUIRED DOCUMENTS ALONGSIDE THE DRAWINGS THIS MIGHT INCLUDE MATERIAL CERTIFICATIONS TEST REPORTS OR OTHER RELEVANT INFORMATION REVIEW AND APPROVAL SECTION DESIGNATED SPACES FOR SIGNATURES DATES AND COMMENTS FROM REVIEWING PARTIES PRACTICAL TIPS FOR SUCCESSFUL SHOP DRAWING SUBMITTAL UNDERSTAND THE PROJECT REQUIREMENTS CAREFULLY REVIEW THE CONTRACT DOCUMENTS AND SPECIFICATIONS TO UNDERSTAND THE REQUIRED LEVEL OF DETAIL AND SUBMISSION PROCESS PREPARE THOROUGH AND ACCURATE DRAWINGS ENSURE DRAWINGS ARE CLEAR CONCISE AND COMPLY WITH INDUSTRY STANDARDS USE CONSISTENT SCALES AND NOTATIONS SUBMIT DRAWINGS EARLY SUBMITTING DRAWINGS WELL IN ADVANCE OF THE DEADLINE ALLOWS AMPLE TIME FOR REVIEW AND CORRECTION MAINTAIN OPEN COMMUNICATION REGULARLY COMMUNICATE WITH THE REVIEWING PARTIES TO ADDRESS ANY

QUESTIONS OR CONCERNS UTILIZE DIGITAL SUBMISSION PLATFORMS CONSIDER USING DIGITAL PLATFORMS FOR SUBMISSION TO IMPROVE EFFICIENCY AND TRACEABILITY THIS COULD BE THROUGH PROJECT MANAGEMENT SOFTWARE OR DEDICATED ONLINE PORTALS TRACK SUBMITTAL STATUS IMPLEMENT A SYSTEM TO TRACK THE STATUS OF YOUR SUBMISSIONS TO ENSURE TIMELY APPROVAL DOCUMENT ALL REVISIONS KEEP A DETAILED RECORD OF ALL REVISIONS AND RESUBMISSIONS INCLUDING DATES AND EXPLANATIONS UNDERSTAND AND COMPLY WITH REJECTION REASONS ADDRESS ALL CONCERNS RAISED DURING REVIEW 3 AND RESUBMIT PROMPTLY WITH CORRECTED DRAWINGS AVOIDING COMMON PITFALLS LATE SUBMISSIONS MISSED DEADLINES LEAD TO PROJECT DELAYS AND POTENTIAL PENALTIES INACCURATE OR INCOMPLETE DRAWINGS ERRORS IN THE DRAWINGS CAN RESULT IN COSTLY REWORK AND DELAYS POOR COMMUNICATION LACK OF COMMUNICATION CAN LEAD TO MISUNDERSTANDINGS AND CONFLICTS IGNORING FEEDBACK FAILING TO ADDRESS REVIEW COMMENTS CAN CAUSE FURTHER DELAYS AND DISPUTES LACK OF ORGANIZATION POORLY ORGANIZED SUBMISSIONS CAN MAKE THE REVIEW PROCESS DIFFICULT AND TIMECONSUMING THE POWER OF PROACTIVE MANAGEMENT PROACTIVE MANAGEMENT OF THE SHOP DRAWING SUBMITTAL PROCESS IS CRITICAL TO PROJECT SUCCESS BY USING A STANDARDIZED FORM MAINTAINING METICULOUS RECORDS AND FOSTERING OPEN COMMUNICATION YOU CAN SIGNIFICANTLY REDUCE THE RISK OF DELAYS REWORK AND DISPUTES INVESTING IN A WELLDEFINED SYSTEM AND TRAINING YOUR TEAM ON BEST PRACTICES CAN SAVE TIME AND MONEY IN THE LONG RUN THE PROCESS ISNT MERELY ABOUT COMPLETING PAPERWORK ITS ABOUT ENSURING THE PROJECTS INTEGRITY AND FACILITATING A SMOOTH WORKFLOW FROM CONCEPTION TO COMPLETION CONCLUSION THE CONSTRUCTION SHOP DRAWING SUBMITTAL FORM IS MORE THAN JUST A PIECE OF PAPERWORK IT IS A CORNERSTONE OF EFFECTIVE COMMUNICATION AND PROJECT MANAGEMENT BY UNDERSTANDING ITS PURPOSE KEY ELEMENTS AND BEST PRACTICES YOU CAN TRANSFORM A POTENTIALLY CHAOTIC PROCESS INTO A STREAMLINED AND EFFICIENT SYSTEM INVESTING TIME AND RESOURCES IN MASTERING THIS CRITICAL COMPONENT WILL UNDOUBTEDLY LEAD TO SMOOTHER PROJECT EXECUTION REDUCED COSTS AND A HIGHER LIKELIHOOD OF SUCCESSFUL PROJECT DELIVERY THE METICULOUS ATTENTION TO DETAIL DURING THIS SEEMINGLY

IF YOUR SHOP DRAWINGS ARE REJECTED YOU'LL TYPICALLY RECEIVE FEEDBACK OUTLINING THE REASONS FOR REJECTION YOU'LL NEED TO ADDRESS THOSE CONCERNS BY REVISING THE DRAWINGS AND RESUBMITTING THEM KEEP DETAILED RECORDS OF THE REVISIONS AND RESUBMISSION PROCESS

2 WHAT IS THE BEST WAY TO TRACK THE STATUS OF MY SUBMISSIONS

USE A COMBINATION OF DIGITAL TRACKING SYSTEMS IF AVAILABLE PHYSICAL LOGS AND CONSISTENT COMMUNICATION WITH THE REVIEWING PARTIES A DEDICATED PROJECT MANAGEMENT SOFTWARE CAN SIGNIFICANTLY ENHANCE THIS PROCESS

3 CAN I USE A GENERIC SHOP DRAWING SUBMITTAL FORM FOR ALL PROJECTS

WHILE A GENERAL TEMPLATE CAN SERVE AS A STARTING POINT ITS BEST TO ADAPT THE FORM TO EACH SPECIFIC PROJECTS REQUIREMENTS CONTRACT DOCUMENTS AND PROJECT SPECIFICATIONS OFTEN DICTATE SPECIFIC INFORMATION NEEDED ON THE FORM

4 WHAT SOFTWARE CAN HELP MANAGE SHOP DRAWING SUBMISSIONS

SEVERAL PROJECT MANAGEMENT SOFTWARE SOLUTIONS SUCH AS PROCORE AUTODESK BIM 360 AND PLANGRID OFFER ROBUST TOOLS TO MANAGE SUBMITTALS TRACK REVISIONS AND FACILITATE COLLABORATION

5 WHAT ARE THE LEGAL IMPLICATIONS OF SUBMITTING INCORRECT SHOP DRAWINGS

SUBMITTING INCORRECT SHOP DRAWINGS CAN LEAD TO LIABILITY FOR THE SUBCONTRACTOR AND POTENTIAL DELAYS AND COST OVERRUNS FOR THE ENTIRE PROJECT IN EXTREME CASES IT COULD EVEN RESULT IN LEGAL ACTION THEREFORE ACCURACY AND THOROUGHNESS ARE PARAMOUNT
